ORDER

Scrutiny of the Notification read on 1st paper above revealed that the rates of remuneration was too higher than the Government rates. Hence the rates are to be revised according to Government norms. So as per reference read (2) above Dr. Abdul Bari N, Academic Co-ordinator (Exam) KSOS, Thiruvananthapuram has submitted proposal for modification of 'Rates of Remuneration' and contingent expenditure under appendix - 7 of the notification dtd. 20.08.2015. The rates of remuneration is modified as mentioned below.

I. TA, Remuneration to Examiners

1. (i) Asst. Examiner - (a) Rs. 8/- per paper having maximum 100 marks.
(b) Rs. 6/- per paper having maximum 50 marks.

(An Assistant Examiner is required to value 13 answer scripts each in the FN and AN session for the examination having 100 marks. Otherwise having maximum 50 marks, the Assistant Examiners to be valued 18 Answer Scripts each in FN and AN session)

- (ii) Chief Examiner

Revaluation and Scrutiny of answer sheets

- (a) Rs. 8/- per paper having maximum 100 marks
(b) Rs. 6/- per paper having maximum 50 marks

(A Chief Examiner is required to be revalued and scrutiny atleast 15%. (10% for revaluation, and 5% for scrutiny) answer scripts out of answer scripts valued by Asst. Examiner not exceeding 10)

- (iii) Remuneration for Camp Officer, Peon & Sweeper

- (a) Camp Officer - Rs.110.50 per day for actual number of valuation days + 2 days
(b) Peon - Rs.65/- per day for actual days of valuation
(c) Sweeper - Rs.100/- per day for actual number of valuation days + 2 days

I (A) TA/ DA for Valuation Staff


1. Upto 8 Km. - No TA
2. Above 8 Kms to 32 Kms - ½ DA
3. Above 32 Km - 1 DA

(Rate of DA as per KSR rates based on basic pay)

I (B) Contingent Charges

Contingency charges including stationery and unforeseen expenditure - 25 paise per script
